Required Activity -- 2023-2024 School Year**

Notification of Formal Evaluation

Evaluator notifies tenured teacher within the first 4 weeks of a unit member's date of paid service. **September 1** (on or before)



Goal Setting Conference

Within 4 weeks after notification of evaluation, the teacher and evaluator will meet to establish goals for the basis of the evaluation. **September 29** (at the latest)



1st Formal Observation and Post Observation Conference

Completed within the first 12 weeks of the unit member's first date of paid service. **October 27** (on or before) Post observation conference held within 5 days of the observation. Documentation of observation submitted within 10 days.



2nd Formal Observation for Teachers with Unsatisfactory Performance

Shall take place within 20 weeks of unit member's first date of paid service **January 12, 2024** (on or before), or if paid service is at the beginning of the second semester, no later than **May 1st**.



2nd Formal Observation and Post Observation Conference

Complete no later than **May 1**. Post observation conference held within 5 days of the observation. Documentation of observation submitted within 10 days.



Summative Evaluation

The summative evaluation is to be completed and signed by both parties by **May 15, 2024** (Wednesday)

Notification of Formal Evaluation

Evaluator notifies probationary teacher within the first 4 weeks of a unit member's date of paid service. **September 1** (on or before)



Goal Setting Conference

Within 4 weeks after notification of evaluation, the teacher and evaluator will meet to establish goals for the basis of the evaluation. **September 29** (at the latest)



1st Formal Observation and Post Observation Conference

Completed within the first 12 weeks of the unit member's first date of paid service. **October 27** (on or before) Post observation conference held within 5 days of the observation. Documentation of observation submitted within 10 days.



2nd Formal Observation and Post Observation Conference

Within 20 weeks of unit member's first date of paid service- **January 12, 2024** (on or before), or if paid service is at the beginning of the second semester, no later than **May 1st**. Post observation conference held within 5 days of the observation. Documentation of observation submitted within 10 days.



Considering Non-reelection

If a second year probationary teacher is being considered for non-reelection, a conference will be held with the teacher by March 1, 2024.



Summative Evaluation

The summative evaluation is to be completed and signed by both parties by **May 15, 2024** (Wednesday)
